## Eligibility of Applicant (Technical Bid):-

The eligible participants include Handloom & Handicraft Artisans, Individuals, NGOs, Firms and Organisations working for development of handloom & handicraft and upliftment of artisans. A document i.e. Artisan/Weavers card, Certificate etc. related to mentioned activities to be submitted.

## Terms & Condition:-

- 1. Jharcraft expresses to lease out the shops at Jharcraft Urban Haat, Parasnath, Giridih for a specific period of 3 (Three) years.
- 2. Jharcraft expresses to lease out the shops @ Rs.800/- per month for (10ft x 8ft.) per shop (Rs.10/- per sq.ft) as per following condition :-
  - A) Rent will be paid prior one month in advance.
  - B) Allotment of shops will be made on first come first serve basis, if the application is less than number of shops.
  - C) If number of application is more than the no. of shops than the condition for selection of lease will be on the basis of lottery.
- 3. All the expenses like electricity, cleaning, day to day recurring expenses etc. of shops shall be borne by the agency/lessee after the lease execution.
- 4. All the taxes & Govt. liabilities etc. will be borne by the agency/lessee after the lease execution.
- 5. The rent as fixed shall be deposited in specified bank on or before 7<sup>th</sup> of every month failing which a penalty of Rs. 100/-per month shall be imposed on the agency/lessee.
- 6. In the event of non-compliance of any of the clause, Jharcraft reserves the right to cancel/reject the lease at any time without assigning any reason thereof.
- 7. The agency/lessee shall not be entitled to make any permanent structure in the rented premises except installation of temporary decoration, wooden partition etc. without the prior consent of Management.
- 8. The agency/lessee cannot claim or take out the developed infrastructure after completion of lease tenure.
- 9. The agency/lessee shall carry on all day to day minor repairs at his/her own cost.

- 10. The agency/lessee shall abide by all the bye- laws, rules and regulations, of the Jharcraft/Local authorities.
- 11. The decision of Managing Director, Jharcraft shall be final in case of any dispute.
- 12. Jharcraft reserves the right to modify terms & condition of shops let out depending upon the future prospect and commercial aspect.
